- d) Ontario Drinking Water Stewardship Program Update:
 - o Ronda Boutz reviewed the staff report with the Raisin-South Nation Source Protection Committee to provide an update on the 2008-09 Ontario Drinking Water Stewardship Program.
 - o It was noted that maximums have been increased from 50% to 80% for some of the Early Actions grants. It was also noted that Conservation Authorities are not allowed to be lead applicants on the new Outreach and Education proposals; however, they can still partner and administer projects. The MOE strategy for this change being that municipalities would take the lead on proposal submissions. It was pointed out that many municipalities do not have the staffing and expertise to perform this function and jurisdictional issues impede this process.
 - It was also noted that Swan Lake in the Oak Ridges Moraine had been purchased outright with financial assistance from an external source. Katie Fairman will attempt to determine this source and advise the Committee.
 - o It was further noted that the issue of water quality is not included in this program with the MOE strategy being that proposed activities in this regard are not approved since the issue of water quality is already being addressed in the technical studies for the assessment reports.
 - o It was also further noted that any not for profit group can make application for

funding. This potentially results in the local Source Protection Committee and Conservation Authorities not being consulted or included as well as inconsistent messaging. MOE will ensure that all proposals submitted will be forwarded to the Committee.
